

**A RESOLUTION OF THE BOARD OF DIRECTORS  
OF THE ALPINE FIRE PROTECTION DISTRICT  
ESTABLISHING THE AUTHORIZATION OF FEE WAIVERS FOR THE  
REBUILDING OF LEGAL STRUCTURES DAMAGED OR DESTROYED IN THE  
WEST FIRE**

**RESOLUTION # 18/19-03**

**BE IT RESOLVED BY THE**, Board of Directors of the Alpine Fire Protection District,

**WHEREAS**, pursuant to Health and Safety Code Section 13919, the Board of Directors shall adopt a resolution that specifies the policy and procedure governing waivers; and

**WHEREAS**, on July 6th 2018, the West Fire broke out in Alpine near Interstate 8 and West Willows Road prompting evacuations and road closures; and

**WHEREAS**, due to extreme weather conditions, characterized by extreme high temperatures, dangerous wind gusts and low humidity, the wildfire quickly began to burn out of control charring over 509 acres; and

**WHEREAS**, as of July 9<sup>th</sup>, 2018 at least 49 homes, 26 accessory structures and 1 commercial building have been either damaged or destroyed by the West Fire; and

**WHEREAS**, in an effort to assist property owners in the areas of San Diego County who lost legal structures in the perimeters of this fire, and who now must fight through the strenuous pain to rebuild their lives; and

**WHEREAS**, it would not be in the public interest to charge those property owners affected by the West Fire a plan check fee; and

**WHEREAS**, this Resolution will authorize the Alpine Fire Protection District to waive plan check review and permit fees for an applicant who is rebuilding legally built structures of like size and location in the area which has been damaged or destroyed by the West Fire; and


**WHEREAS**, the exact boundaries of the affected wildfires areas will be formalized by the County's Planning & Development Services and the San Diego County Fire Authority, in conjunction with CAL FIRE officials and other regional fire entities, and

**NOW, THEREFORE, BE IT RESOLVED** on this 16<sup>th</sup> day of October 2018 by the Alpine Fire Protection District Board of Directors that property owners victimized by the July 6, 2018 West Fire and within the geographic boundary, shall be eligible for plan check review fee waivers as authorized by this Resolution.


